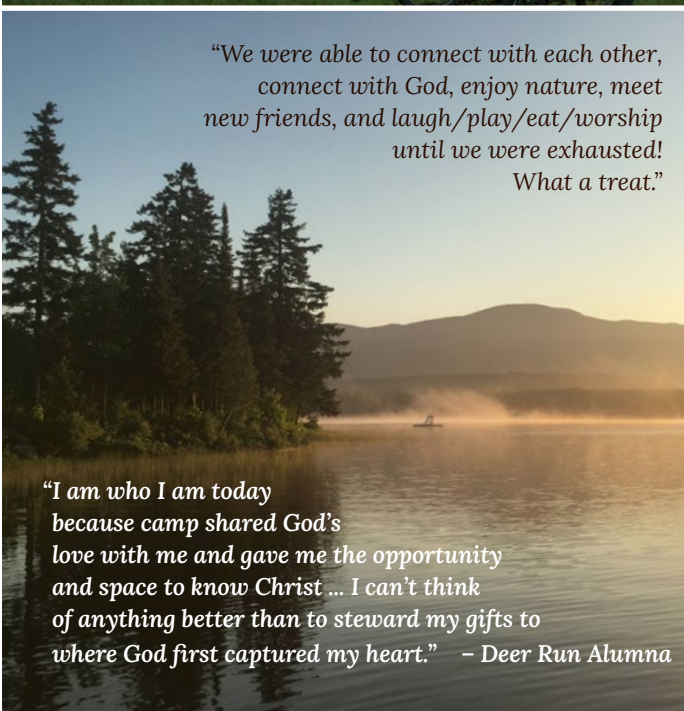

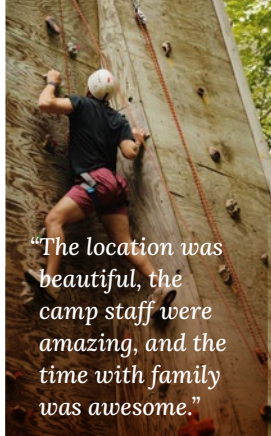

Special considerations for 2020:

The recently enacted Coronavirus Aid, Relief, and Economic Security Act, or CARES Act, has several provisions which affect charitable giving this year.

A summary of some of the provisions are below:*

- **Charitable Deduction Percentage Increased:** For the 2020 tax year only, those who itemize deductions may deduct cash contributions to Christian Camps and Conferences, Inc. and most other public charities to offset up to 100% (ordinarily 60%) of your income. This 100% limit allows especially generous donors to reduce their 2020 federal income tax to zero. Even if you do not itemize your deductions in 2020, you can still reduce your taxable income by up to \$300 for contributions of cash to public charities using an “above the line” adjustment to reduce your taxable income.
- **Most required minimum distributions from retirement plans are waived for 2020.** If you are 70½ or older, a qualified charitable distribution (“QCD” or “IRA charitable rollover”) allows you to make a tax-free gift of up to \$100,000 to CCCI from your IRA. While the required minimum distribution has been waived for 2020, a QCD remains a great way to make tax advantageous contributions, especially if you don’t itemize your deductions.
